What do I do with Latex Paint?

—
Latex paint is not accepted at the
Household Hazardous Material Facility
because it can be disposed of with your
regular trash when the paint is dry.

—
If the paint is still liquid, open the
top and allow the paint to air dry. To
speed up the process, you may also
add sand, cat litter or latex paint
hardener to the liquid paint.
