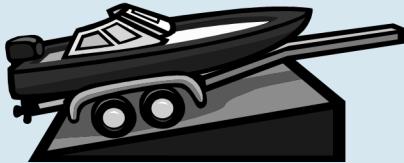


## Boat Launch Locations

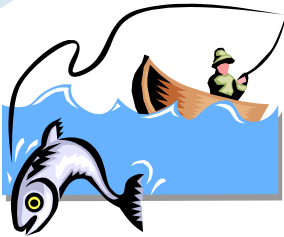

## Launch Permit Program

Over the past several years, communities in Winnebago County have enacted individual Boat Launch programs and established fees to generate much needed maintenance and improvements revenue for the parks waterways and boat launch facilities within their jurisdiction. This program and user fee was initiated in the City of Omro in 2003.

There are three park boat launch site facilities in the City of Omro: Miller Park, Fox & Hounds Park and Stearns Park.

## Municipal Stickers

Each municipality requires a separate sticker for their respective municipally owned launch sites, including a separate sticker for Winnebago County owned launches. Purchase of a City of Omro boat launch permit requires proof of ownership of the towing vehicle. Be prepared to present motor vehicle registration.

## Additional Stickers

When purchasing your initial boat launch sticker, you may receive a second or subsequent sticker free of charge for any additional vehicle you may own and use for launching your boat. Proof of ownership is required.

## Placement of Sticker

Permanently affix the permit sticker to the lower corner of the interior of the windshield on the driver's side of the towing vehicle.

Designating this as a boat launch permit and attaching it to a motor vehicle instead of the boat trailer, empowers the City of Omro to apply enforcement through State Statute 345.28. This Statute cannot be used for a program where a permit and sticker are linked only to a boat trailer. It is solely through State Statute 345.28 that a vehicle license plate number can be legitimately used and a citation issued by the Omro Police Department.

## Permit Fees

Annual Permits are valid from January 1st through December 31st of each calendar year.

City Resident Annual Permit	\$30.00
Non-Resident Annual Permit	\$30.00
Daily Boat Launch Permit	\$ 6.00

May be purchased at City Hall M-F 8:00-4:30

Daily permits may be purchased at the individual launch sites by completing the permit application envelope information and depositing the application portion and fees it into the launch site collection box. Miller Park will soon be offering debit/credit card purchasing on site.
