General Rules and Guidelines

- Responsible party must be at least 18 years of age
- \$50.00 security deposit is required at time of reservation, please make a separate check or cash
 - Security deposit will only be refunded for inclement weather or other reasons by the manager
 - Events may be rescheduled to avoid loss of deposit with manager at least 48 hours prior to event
- Before the conclusion of event, full amount must be paid in full to manager on duty
- Reduced admission is charged for fun deck rental and no admission charged for private party
- Number of lifeguards are determined based on expected attendance, if this number changes notify pool manager immediately. Email: omropool@gmail.com
- Facility use (including cleaning) must not go over specified time in the rental agreement
 - If rental runs over specified time, you will be charged for the additional hour and will forfeit security deposit
- Renters are responsible for cleaning the area before the end of the specified time
 - Garbage receptacles and cleaning supplies will be provided
- Absolutely NO alcohol allowed on OFAC property
 - If alcohol is brought, party will be charged full amount, forfeit security deposit and be required to leave immediately
- Damages and cleaning charges may be added to total amount and will forfeit security deposit as well
- Let guests know that if they arrive early, they will be charged full admission

Private Party Rules

- One (1) adult chaperone over 18 must be present per twenty (20) children ages 1-17
- Guests will be removed from the pool 10 minutes prior to the end of the party
- Normal pool rules apply to the private party, including deep end test rules.
- All areas (slides, diving board) may not be open the whole party, areas will be opened throughout party
